CFPB Report – The Consumer Financial Protection Bureau (CFPB) released a report today which found that manufactured-home owners typically pay higher interest rates for their loans than borrowers whose homes were built onsite. The report also found that manufactured-home owners are more likely to be older, live in a rural area, or have lower net worth.

“Manufactured housing is a critical source of affordable housing for some consumers, particularly those who are older, live in a rural area, or have less income and wealth,” said CFPB

Director Richard Cordray. “These consumers may be more financially vulnerable and benefit from strong consumer protections. The Bureau is committed to ensuring that consumers have access to responsible credit in the manufactured housing market.”

Last words for September – Congratulations to **MHOAI**. NMHOA board and staff extend their congratulations to our member association in **Illinois** on the successful passage of HB 4123. This bill has been signed into law and requires that home owners be provided with the name and contact information for their community owner and within 20 days of a community sale, with the name and contact information of the new owner. More importantly, this new law also ensures enforcement of the statute by the Dept. of Health.
