**National Community Land Trust Network Annual Conference, Lexington Kentucky**, - NMHOA Executive Director, Ishbel Dickens, was invited to the National Community Land Trust (NCLT) conference held in Lexington, Kentucky, in October. She was one of a panel of experts (including Doug Ryan, CFED; Cathy Haigh, ROC USA; Harold Simon, Shelterforce) invited to share their knowledge with community land trust staff and board members as they consider the possibility of adding the preservation of manufactured housing communities to their portfolios.

Ishbel sees community land trusts and manufactured housing communities as natural partners – what better combination than benevolent non-profit ownership and stewardship of the land directly tied to home owners who desire long-term security of tenure and affordable rents.

It is exciting to note that alternative preservation models are providing additional options for homeowners' associations who are working to save their communities. We now have resident-owned communities, non-profit and housing authority owned communities, and community land trust communities. Homeowners now have choices when they want to save their parks. With 50,000 land-lease communities across the country there are plenty of opportunities for any one of these models to be the right fit and the playing field is big enough for all of them to go to scale without feeling the need to compete against each other for any particular preservation project.

Welcome to the field, **NCLT** – NMHOA is here to assist you in any way we can.

**Good News from Congress** – In early December, NMHOA members were asked to contact their U.S. Senators regarding Section 909 of S. 1910 – the section of the Appropriations bill that would have greatly weakened the Dodd Frank Act's consumer protections.

Many thanks to those of you who took the time to make those calls.

The good news is that on December 15<sup>th</sup>, Congress agreed to a spending bill that: 1. Would prevent the federal government from shutting down later this week; and 2. Removed any reference to policy riders that would undercut the financial and lending reforms enacted by the 2010 Dodd–Frank Wall Street Reform and Consumer Protection Act.

Among the bills that Congress left out of the appropriations bill is H.R. 650/S. 682, the manufactured housing industry-written bill that would undercut consumer protections on high-cost loans and loan product steering. (I.e. Section 909) This is a victory for consumers. However, we will need to remain vigilant in 2016 since H.R. 650 had passed the full House, and a Senate committee, earlier this session, so the threat remains real.

**Presidents' Connection** – As many of you know, Kylin Parks, NMHOA Community Organizer, hosts monthly conference calls for the presidents (or their designee) of our state association members – this is an excellent opportunity for people to learn from each other and to share successes as well as challenges for collective problem solving.
