Debate continues on overdue 2022 federal spending bill, including future of proposed manufactured housing program

Members of Congress are working to enact an overdue FY22 appropriations bill, including a scaled-back “Build Back Better Act.” On February 9, U.S. House of Representatives and U.S. Senate leaders announced a bipartisan agreement on a “framework” for the spending package, but decisions are still being made about how to divvy up funding among the 12 spending bills that make up the federal budget. After a recess in February, leaders will soon make key decisions.

The bill as passed the U.S. House of Representatives would invest \$150 billion in affordable housing priorities, such as: \$25 billion to expand rental assistance; \$65 billion to preserve public housing; and \$15 billion to build and preserve homes through the national Housing Trust Fund. It also includes a new \$500 million **Manufactured Housing Improvement Grant** program, in order to address critical health and safety issues. To be eligible for an improvement grant, a community must either be resident-owned or enter into a binding agreement to be maintained as a manufactured home community and remain affordable for low-income families.

Over 3.2 million households received rental assistance in 2021

The **U.S. Department of the Treasury** reported \$18.5 billion was spent in 2021, providing emergency rental assistance to more than 3.2 million households. Nearly two-thirds of households served had extremely low incomes. However, the federal government provided states with \$46.55 billion and states had widely varying results in getting relief to low-income renter households. While 13 states distributed 70% or more of their funds, there were 14 states that have used 25% or less, despite having high numbers of low-income renters.

U.S. DOE Energy Efficiency Standards

The **Energy Independence and Security Act of 2007 (EISA)** directed the **U.S. Department of Energy (DOE)** to establish energy conservation standards for manufactured housing based on the most recent version of the **International Energy Conservation Code (IECC)**. DOE proposed a tiered approach to address affordability and cost-effectiveness concerns. NMHOA was among the 234 groups and individuals that submitted comments. DOE has now published a **draft environmental impact statement (EIS)** analyzing the impacts of the standards for manufactured housing. Comments can be provided through February 28.
