CFED Convening – Portland OR - NMHOA staff (Ishbel Dickens and Kylin Parks) along with NMHOA Secretary, **Rita Loberger**, were thrilled to attend CFED's Convening in Portland, Oregon last week. 90 attendees from affordable housing advocacy groups, financiers, funders, legal services and home owners' associations enjoyed a full day of presentations.

NMHOA looks forward to continuing to work with **CFED**, **ROC USA**, **and Next Step** as together we forge new paths and create new partnerships to support manufactured housing initiatives in Portland and elsewhere in Oregon.

Manufactured Housing Consensus Committee (MHCC) meeting, Louisville Kentucky, - HUD hosted its first in-person meeting of the MHCC at the manufactured home show in Louisville in mid-January. NMHOA E.D., Ishbel Dickens and At-Large Board member, **Gary Miller** are consumer representatives of the 21 person MHCC. This is an important role for NMHOA staff and board members to play since the MHCC establishes federal standards for the design and safety features of new manufactured homes.

Duty to Serve – The Federal Housing Finance Agency (FHFA) has published a proposed rule regarding Duty To Serve (DTS) (a requirement to ensure financing and other opportunities for under-served markets, including manufactured housing). NMHOA staff and board members have been in conversations regarding DTS and are currently formulating a comment letter in response. The deadline for comments is March 16, and if you would like to know more about DTS and to find out how your HOA (state or local) can submit comments please contact Ishbel Dickens at: ishbel@nmhoa.org In addition, CFED is hosting a webinar on DTS at 2pm (Eastern) on Tuesday February 9. Again, please contact Ishbel if you would like to participate in this webinar.
